SECTION 3 - RISK/HAZARD IDENTIFICATION

SECTION 7 - STORAGE AND HANDLING

SECTION 8 - PRECAUTIONS TO CONTROL EXPOSURE / PERSONAL PROTECTION

System Design If ventilated cabinet, enclosure or fume hood is necessary, average airflow should be at least 100 FPM (50.8 cm/sec).

Monitoring: Maintain breathing zone airborne concentrations below exposure limits (see section 2).

Prevent inhalation of the solvents. Use in a well-ventilated room. Open doors and/or windows to ensure airflow and air changes. Use local Breathing Protection:
